

The Head & Shoulders Super Bowl LIV Sweepstakes at Walmart

Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The Head & Shoulders Super Bowl LIV Sweepstakes at Walmart (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia), who are at least eighteen (18) years old at the time of entry. Void where prohibited. Proof of residency and age may be required. Employees and directors of Sponsor, Sync Marketing LLC, Walmart Inc., the NFL Entities (as defined below), and their subsidiaries, divisions, affiliates, and advertising or promotional agencies or individuals involved with the design, production, execution or distribution of the Sweepstakes and the immediate family and household members of such individuals, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, regardless of where they live. "Household members" shall mean people who share the same residence at least three months a year, whether related or not. In order to enter the Sweepstakes or receive a prize, you must fully comply with the Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions shall be binding and final in all respects relating to this Sweepstakes. 3. Timing

Sweepstakes begins September 25, 2019 at 12:01 a.m. Eastern Time and ends December 1, 2019 at 11:59 p.m. Eastern Time ("Sweepstakes Entry Period"). Administrator is the official time keeper for this Sweepstakes.

4. How to Enter

There are two (2) ways of entering during the Sweepstakes Entry Period:

- A. **Enter by purchasing a qualifying Head & Shoulders product from Walmart or Walmart.com and uploading an image of the receipt or shipping confirmation:** You can receive one (1) entry when you purchase a qualifying Head & Shoulders product at Walmart or Walmart.com during the Sweepstakes Entry Period. entry for each unique qualifying Head & Shoulders product included on the receipt. Each receipt may only be uploaded once.

For Walmart.com purchase(s):

1) upload an image of the shipping confirmation that shows the qualifying purchase(s), date of purchase(s) and that product(s) were purchased at Walmart.com; and 2) provide your first name, last name, email address and phone number in the spaces provided. You will receive one (1) entry into the Sweepstakes for each qualifying Head & Shoulders product purchased when you complete this process. You will receive one (1) entry for each unique qualifying Head & Shoulders product included on the shipping confirmation. Each shipping confirmation may only be uploaded once.

Limit of fifty (50) entries per person during the Sweepstakes Entry Period for entering by purchasing a qualifying Head & Shoulders product from Walmart or Walmart.com and uploading an image of the receipt or shipping confirmation. Eligible Head & Shoulders products are:

- B. **Enter by Mail:** During the Sweepstakes Entry Period print your first name, last name, email address and phone number on a 3x5 card and mail it to: Head & Shoulders Super Bowl LIV Sweepstakes at Walmart c/o Sync Marketing LLC, 5662 Calle Real #214, Goleta, CA 93117. Mail in entries must be postmarked within the Sweepstakes Entry Period and received by December 8, 2019. You will receive one (1) entry for each card received. Limit of fifty (50) entries per person during the Sweepstakes Entry Period for mailing in.

Limit of fifty (50) entries per person during the Sweepstakes Entry Period regardless of method of entry.

Entrants may only use one email address to enter the Sweepstakes. You are not permitted to share the same email address with another entrant. Use of any automated system to enter is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries all of which will be ineligible to win a prize. In the event of a dispute as to any entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder to be awarded the prize. All entries become the sole and exclusive property of Sponsor and will not be returned or cancelled.

5. Winner Determination

On or about December 11, 2019 Administrator will randomly select one (1) entry for each prize described below in a random drawing of all valid entries received. The potential winners will be contacted using the email address and/or phone number provided with the entry and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. The potential winners will be notified by email and/or phone on or about December 11, 2019. Failure by potential winners to respond to the initial verification within forty-eight (48) hours of notification after three (3) attempts will result in disqualification and Administrator will select an alternate potential winner in the same manner. Odds of winning depend on the number of eligible entries received during the Sweepstakes Entry Period. Limit of one prize per person / per household.

6. POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR AND/OR ADMINISTRATOR. SPONSOR AND ADMINISTRATOR’S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE ADMINISTRATION, OPERATION, SELECTION OF THE WINNERS AND OTHER MATTERS RELATED TO THE SWEEPSTAKES.

7. Verification of Potential Winners

Potential winners may be required to complete and return an Affidavit of Eligibility, Release of Liability and Publicity Release (where permitted by law) (collectively, the "Affidavit") by the date specified by Sponsor, or an alternate potential winner may be selected. In the event: (a) potential winner cannot be reached for whatever reason after a reasonable effort has been exerted or the potential winner notification or Affidavit is returned as undeliverable; (b) potential winner declines or cannot accept, receive or use the prize for any reason; (c) of noncompliance with the above or within any of the aforesaid time periods, (d) potential winner is found to be ineligible to enter the Sweepstakes or receive the prize, (e) potential winner cannot or does not comply with the Official Rules, or (f) potential winner fails to fulfill the Affidavit-related obligations, the potential winner shall be disqualified and an alternate potential winner may be selected, at Sponsor's sole discretion, from among the other eligible entries received. Sponsor reserves the right to modify the notification and Affidavit procedures in connection with the selection of alternate potential winner, if any.

8. Grand Prizes

Two (2) grand prizes will be awarded. Each grand prize winner will receive a 3-day/2-night trip to Miami, FL for winner and one (1) travel companion to attend Superbowl LIV on February 2, 2020.

Trip includes roundtrip air transportation (coach) for up to two (2) people from a major U.S. gateway airport nearest the winner's home to Miami, FL, hotel accommodations (one (1) standard room, double occupancy for two (2) nights) and two tickets Superbowl LIV on February 2, 2020. Trip will depart for Miami, FL on or about February 1, 2020 and will return on February 3, 2020 (collectively the "Grand Prize"). All dates determined by the Sponsor in its sole discretion. If winner is unable to travel on the specified dates the prize will be forfeited and no other compensation will be provided. If winner lives within 150 miles of Miami, ground transportation will be provided. All expenses and incidental travel costs not expressly stated in the package description above, including but not limited to, ground transportation, baggage fees, personal charges at lodging, security fees, taxes or other expenses or incidentals are the responsibility solely of winner. Travel companion must be 18 or older at the time of travel or winner must be the parent or legal guardian of the travel companion. Travel companion will be required to execute a Release of Liability/Publicity Release (where legal) prior to departure. Winner and travel companion must travel at the same time and on the same itinerary. Winner and travel companion are required to have all necessary travel documents (i.e., valid Government ID and/or Passport). Approximate retail value of each Grand Prize is \$10,000. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Sponsor, their sole responsibility to the winner will be to award the remaining available elements of the prize and no substitution or compensation will be provided for the unawarded elements of the prize. If Super Bowl LIV is canceled or postponed, no other consideration or prize will be provided. Sponsor in its sole discretion, reserves the right to deny entry to or to remove the winner and/or guests if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person during any part of the trip.

No cash equivalent for the prize, prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the listed prize for one of equal or greater value for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. All federal, state, and local tax liabilities, as well as any other costs and expenses not specified herein as being awarded are the sole responsibility of the Winner. Winner may be

required to complete and return an IRS W-9 form (i.e. Request for Taxpayer Identification Number and Certification). Prize will be awarded only if the potential prize winner fully complies with these Official Rules. The total ARV of all prizes is \$20,000.

9. Entry Conditions and Release
